



Call for applications Erasmus+ KA171 scholarships for incoming Student mobility, Teaching Staff mobility and Training Staff mobility from the following regions: Neighbourhood East (Armenia), South-Mediterranean countries (Morocco, Jordan) and Western Balkans (Albania, Bosnia and Herzegovina) (see below for list of eligible universities)

The University of Novi Pazar holds the Erasmus Charter for Higher Education (2021-2027).

Within the ERASMUS+ Project 2022-1-RS01-KA171-HED-000077440 referring to cooperation with higher education institutions in the partner countries, the University of Novi Pazar announces the <u>Call for applications</u> for awarding financial support to students and teaching and/or non-teaching staff mobilities, the objective of which is studying, teaching or training at the University of Novi Pazar (further in the text: UNINP). All incoming and outgoing activities supported within this call are coordinated and administered by the University of Novi Pazar.

Purpose of the Call The main purposes of this call are:

- study periods: this activity allows students to study abroad at a partner higher education institution (HEI);
- teaching periods: this activity allows HEI teaching staff or staff from enterprises to teach at a partner HEI abroad.
- training periods: this activity supports the professional development of HEI teaching and non-teaching staff in the form of training events abroad (excluding conferences) and job shadowing/observation periods/training at a partner HEI, or at another relevant organisation abroad. A period abroad can combine teaching and training activities.

In the framework of the Erasmus+ Programme, all mobility activities are conditional upon signing an inter-institutional agreement between the sending and the receiving universities before the start of the mobility.





## **Application deadline**

Application deadlines are:

- <u>For student mobilities</u> Students have to apply at least **a month** before the beginning of each semester, depending on which semester was planned.
- <u>For teaching/staff mobilites</u> The mobilites for teaching and/or staff training can be realized throughout the entire school year, for inquiries about available dates contact <u>iro@uninp.edu.rs</u>

By submitting the application to this call, all applicants agree that the University of Novi Pazar publishes their personal data on the web page within the selection procedures and further uses their personal data within the administration procedures and reporting.

Applications incomplete and/or received after the deadline will not be taken into account for the evaluation process.

- **3.** Transcript of Records verified from the Home University, translated into English, with clear grading system explanation
- **4.** Motivation letter in English
- **5.** Proof of English language proficiency (Certificate of language schools or transcript of records or certificate of high school or a passed English exam on the transcript of records)
- **6.** Learning Agreement signed by the home institution
- 7. Consent form to publish personal data

- 3. Certificate of employment of the home institution

- 5. Consent form to publish personal data

#### Rights of the beneficiary

- -To receive the scholarship according to the amounts set out in the Erasmus+ Programme guidelines. The expenses not covered by the scholarship will be borne by the beneficiary.
- To receive information and advice on the application procedure, as well as pre-departure and on-site guidance.
- -To have the teaching and training period abroad recognized by the sending university.





## Obligations of the beneficiary

- - To take out and prove to be in possession of adequate insurance throughout the mobility period according to the Erasmus+ programme rules.
- - To obtain visa for the stay in the receiving country To carry out the mobility stay according to the proposal and dates committed.
- - To complete all procedures and fill in the required documents as required by the Erasmus+ Programme, before, during and after the mobility period, meeting the deadlines established by the University of Novi Pazar.
- Any other obligation inherent to the Erasmus+ Programme and the internal regulations of the sending and receiving institutions.
